This charge is for re-establishing service after disconnection for non-payment, failure to make deposit, fraudulent or seasonal use.

**TAP-IN-FEE (non-pressurized systems)**                      **\$ 150.00**

This charge is to the first homeowner of a home provided the contractor does the tap-in with Company called to inspect it.

**\$ 450.00**

This charge will include all labor and materials and any other costs associated with initially establishing service. This charge does not include the cost of the yard lines, road bores or driveway bores.
